Student's Statement of Certification, Understanding, and Agreement

Persons must meet each of the following conditions, as listed in the Arizona Revised Statutes 15-1809 to participate in this program.

I certify that I reside in Arizona and I am currently in foster care and at least 16 years of age* or / was in foster care when I was at least 16 years of age* or / was adopted from foster care and the adoption was finalized after I was 16 years of age*. In addition:

I am a United States Citizen or a noncitizen who is lawfully present in this country.

I am under 23 years of age.

I have been accepted into or enrolled in a degree, certificate or other accredited program within the Maricopa Community Colleges District.

I will demonstrate continued satisfactory academic progress under the Maricopa Community Colleges District's academic standards for a degree or certificate in order to remain eligible for the foster care supplemental tuition waiver program.

If it is determined that I am not eligible for a waiver, I am responsible for paying the full student cost of any courses I am enrolled in as of the drop/add period for the course(s). Eligibility may or may not be verified prior to the end of the drop/add period.

The number of withdrawals for the same course number (i.e., ECN211) is limited to two (2). Upon the third attempt, I may not use a tuition waiver to register for any course for which I have previously received two W, Y, Z or F grades and I must pay applicable course costs. The intent of this limitation is to address the potential (or possible) misuse of public funds for any activity indicating a pattern of non-participation, non-attendance and non-completion (e.g., multiple withdrawals or "Z" grades).

I understand that I am eligible for a tuition waiver for up to sixteen (16) credit hours per semester.

I have completed and submitted a United States Department of Education A Free Application for Federal Student Aid (FAFSA) application for the current school year. I understand the supplemental tuition waiver program at the Maricopa Community Colleges District will only cover the remainder of the balance of tuition costs and I must receive verification that I am eligible for the tuition waiver supplemental program.
